What is Local Lawyers in Schools?

Local Lawyers in Schools places trainee and practising lawyers in the classroom to explore a range of legal issues to develop young people's awareness and understanding of the law.

The Citizenship Foundation has been connecting legal professionals and schools for over 20 years. Responding to popular demand, Local Lawyers in Schools has now been developed to specifically suit small and medium-sized legal organisations keen to make a difference to their local community.

What is involved?

The programme fits around the lawyers' busy schedules. It's easy to sign up and you will be given all the information needed for every step of the process.

Over the course of a year, lawyers from your office will use specially created activities and resources to run **engaging, interactive sessions with groups of students at your local school** on a range of legal issues.

Before these sessions start, a trainer from the Citizenship Foundation will visit you to run sessions on **how to set up and run the scheme** in your office and **how to use the resources** with young people.
